Who should attend?

Corporate politics, power. We all know it exists in organizations. Even if you don't want to "play the game" you need to know and understand "it" to successfully manage your career. During this stimulating workshop, you will explore the concepts of power

and leadership, acquire critical skills to master the dynamics of power and develop effective career strategies.

Leading With Vision

Learn the attributes of successful leaders in today's diverse workplace. Draft and develop your personalized action plan through the application and interpretation of the results of your 360-degree leadership assessment survey. Complete this section with a session on developing your leadership vision.

The Power of Networking and Career Development

Is your idea of networking passing out business cards at a party? Think again. Challenge traditional views of networking and learn the art of building a community through personal relationships. This session will teach an accessible and enjoyable form of personal strategic planning and the fundamentals of networking as a means for both professional and personal fulfillment.
